## **SOFTWARE LICENSE AGREEMENT**

### **1. License provision**

The engineering office Waltemath and the reseller Plaspittec GmbH (hereinafter called 'producer') grants you a simple, non-transferable license for the use of the enclosed computer program (hereinafter called 'software') on investments which are held by you or which are under your supervision, according to the following conditions.

This license agreement allows the single user the use of the software on only one computer at one place to a given time.

### **2. Limitations**

### **3. Copyright**

A claim may only be made if the faulty data carrier (s) are returned within 90 days after the date of delivery. Except for the above-mentioned limited warranty the producer is not given any further warranty duty. No explicit, implicit or statutory guarantees or guarantees given in written notice or verbal messages are guaranteed. The producer refuses any further guarantee, including the customary guarantee or the suitability for a specific purpose.
